It is the member's responsibility to return the ballot to the election committee by Email, U.S. mail or by hand, not verbally or by text message.

WHEN CONNIE DIED IN FEBRUARY 1995 AFTER BATTLING CANCER FOR FIVE YEARS, I BECAME QUITE LONELY AS YOU WOULD EXPECT. AFTER A PROPER PERIOD OF TIME. I TOOK OUT A FEW SINGLE LADIES WHO WERE ALSO LONELY INCLUDING DORIS. IT WASN'T LONG BEFORE I DECIDED I HAD TO CUT OUT THE GAMES, AFTER DORIS SAID TO ME ON ONE OCCASION, "IF YOU ARE GOING TO BE THE DON-JUAN OF SHADY LANE OAKS, I'M NOT SURE I WANT TO BE PART OF YOUR HAREM!" WELL, THERE WAS NO DOUBT IN MY MIND WHO I WANTED AND, IT WAS DORIS OF COURSE. OUR RELATIONSHIP GREW INTO TRUE AND DEVOTED LOVE AND WE BEEN "SIGNIFICENT OTHERS." FOR FIFTEEN WONDERFUL YEARS. DORIS WAS A FRIEND AND NEIGHBOR OF MY WIFE CONNIE AND I IN SHADY LANE OAKS. THE MOBILE HOME COMMUNITY WE MOVED TO IN 1987. THOSE WHO HAVE SEEN IT WILL AGREE IT WAS A BEAUTIFUL HOME IN A BEAUTIFUL SETTING ON A SMALL LAKE. LOTS OF TREES, HANGING BASKETS IN THE WOODS NEXT TO US. IT WAS A DOUBLE WIDE 28 FT WIDE X 54 WIDE WITH A 12 X 24 GLASSSED IN PORCH ON THE LAKE SIDE WITH HEAT AND AIR. THAT'S WHERE WE SPENT MOST OF OUR TIME. THE PREVIOUS OWNER, WAS THE OWNER OF THE PARK AND HAD THE WHOLE HOUSE WIRED FOR SOUND AND THE NECESSARY COMPONENTS TO PLAY IT. DORIS SUFFERED FROM OSTEOPOROSIS. A YEAR AGO, EARLY IN JANUARY, SHE FRACTURED A BONE ON HER SPINE SIMPLY BY PULLING AT A SWEATER THAT HAD BUNCHED UP, PREVENTING HER FROM BUCKLING HER SEAT BELT IN MY CAR. IT REQUIRED SURGERY AND SHE HAD SUFFERED FROM A GREAT DEAL OF PAIN AND HAD BEEN REQUIRED TO USE A WALKER EVER SINCE. MORE RECENTLY SHE FRACTURED HER STERNUM WHILE SIMPLY GETTING OUT OF BED, MORE PAIN. MY GREATEST FEAR WAS THAT I MIGHT DIE BEFORE HER AND LEAVE HER ALONE.

RECENTLY I DISCOVERED HER STOMACH SEEMED SWOLLEN AND EXTREMELY HARD. OUR DOCTOR ORDERED AN ULTRA-SOUND AND DISCOVERED CANCER ON HER LIVER WHICH THEY LATER DISCOVERED BEGAN IN HER COLON. HOSPICE TOOK OVER AND SHE DIED AT HOME UNDER THEIR LOVING CARE 13 DAYS LATER ON JANUARY 22, 2011

A BEAUTIFUL MEMORIAL SERVICE AND THE INTERNMENT OF HER ASHES TOOK PLACE AT OUR ST. JOHN'S EPISCOPAL CHURCH ON FEBRUARY 3RD, 2011.
