#### **Proposed** Marbles (to replace Pinochle)

- A) Marbles will be played as two person teams to be determined by draw.
- B) Marbles boards will have two or three teams, (three is preferred) based on the total number of players.
- C) There will be two or more houses per month depending on number of players.
- D) Each month at least one house will be kid friendly (bring your kids with you).
- E) Each month will be a stand alone competition (prizes paid that night).

- G) Scoring will be as follows:
